PROPOSAL & BACKGROUND

On January 29, 2025, Administration received a letter from the Town of Bonnyville confirming their Council's approval of the Terms of Reference for the Health Professions Attraction and Retention Committee, formerly known as the Physician Retention and Recruitment Committee.

The Town of Bonnyville is also requesting approval of these Terms of Reference by the M.D. of Bonnyville.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

On October 24, 2023 Council passed a motion appointing the Reeve as the representative of the Municipal District of Bonnyville to the Physician Recruitment and Retention Committee in perpetuity.

Discussions with the Bonnyville Health Centre and the Town of Bonnyville have confirmed that the Physician Retention and Recruitment Committee has been taken over by the Town of Bonnyville in the summer of 2023 and renamed to the Health Professions Attraction and Retention Committee.

The renamed Committee's Terms of Reference were approved by the Town of Bonnyville's Council at their Regular Meeting of Council on January 28, 2025.
