# PROPOSAL & BACKGROUND

Administration has been working on a review and update of the Highway 28 and Highway 41 Area Structure Plan (ASP) to ensure that the plan is consistent with the Municipal Government Act (MGA), current practices, municipal policies, and community aspirations. As all municipal ASPs are established by Council through bylaw, Administration is proposing Bylaw No. 1897 for first reading which will repeal and replace the previous Bylaw No. 1693 " Highway 28 and Highway 41 Major Area Structure Plan" passed in 2018, and all amendments thereto.

# **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

Part 17 of the MGA allows municipalities to adopt Area Structure Plans which have the purpose to establish the following guidelines within a designated area: general land use patterns, proposed sequence of development in the area, the overall density of population, transportation networks, and a general framework for municipal services.

The review and update of the Highway 28 and Highway 41 ASP was initiated in April 2024 with assistance from the community consulting firm, Urban Systems. Data was compiled and a draft ASP was completed.

If the proposed bylaw receives first reading, the updated plan information, opportunities to provide perspectives and feedback and the scheduled Public Hearing information will be provided to area residents, landowners, and stakeholders.

The amended Highway 28 and Highway 41 ASP reflects updates on the following:

- 1. Updating the Airport information and name to "Municipal District of Bonnyville Regional Airport".
- 2. Updating the Plan boundaries to run adjacent to the Moose Lake ASP plan boundaries, no longer overlapping.
- 3. Changing the formatting to be consistent with the other recently updated ASPs (Moose Lake, Chickenhill Lake, Crane Lake, Highway 55).
