Title: Removal of Municipal Reserve Designation – Plan 822 1629, Block 2, Lot 11MR

PROPOSAL & BACKGROUND

Administration is requesting Council direct the designated officer to notify the Registrar that the provisions of the *Municipal Government Act* (MGA) have been complied with and request the Registrar to remove the Municipal Reserve designation from Plan 822 1629, Block 2, Lot 11MR within NE-10-62-1-W4M.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

Development of the Cherry Grove Fire Hall on Plan 822 1629, Block 2, Lot 11MR within NE-10-62-1-W4M was approved on Development Permit 2023-D-256.

Removing the Municipal Reserve designation from Plan 822 1629, Block 2, Lot 11MR would be more consistent with the property's existing use as a fire hall.

In accordance with the MGA requirements for municipal reserve designation removal, a Public Hearing was held April 22, 2025, notice of which was advertised for a minimum once a week for 2 consecutive weeks being the March 18 and March 25, 2025, editions of the Lakeland Today newspaper and the March 18, 2025, edition of the Respect newspaper.

Additionally, the notice of the Public Hearing was posted on the M.D. of Bonnyville website and on the Municipal Reserve from March 18 until April 23, 2025.

There were no written submissions or in-person or virtual attendees at the Public Hearing.

Following the public hearing, Council may direct a designated officer to notify the Registrar that the provisions of the MGA have been complied with and request the Registrar to remove the designation of municipal reserve.
