

# APPENDIX A

## BYLAW NO. 1890

BEING A BYLAW OF THE MUNICIPAL DISTRICT OF BONNYVILLE NO. 87, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF CLOSING FOR PUBLIC TRAVEL AND DISPOSING OF PORTIONS OF A PUBLIC HIGHWAY.

**WHEREAS**, under the provisions of the Municipal Government Act, R.S.A 2000, Chapter M-26.1, and amendments thereto, no road in a municipality that is subject to the direction, control and management of the municipality may be closed except by bylaw;

**AND WHEREAS**, under the provisions of the Municipal Government Act, R.S.A 2000, Chapter M-26.1, and amendments thereto, a bylaw closing a road made by the council of a municipality that is not a city has no effect unless it is approved by the Minister of Transportation before receiving second reading;

**AND WHEREAS**, the lands hereinafter described are no longer required for public travel;

**AND WHEREAS**, an application has been made to Council to have the government road allowance closed and sold;

**AND WHEREAS**, a notice of intention of the Council to pass a Bylaw has been given in accordance with the Municipal Government Act, R.S.A 2000, Chapter M-26.1, and amendments thereto;

**AND WHEREAS**, Council was not petitioned for an opportunity to be heard by any person prejudicially affected by the bylaw;

**NOW THEREFORE**, the Council of the Municipal District of Bonnyville No. 87, duly assembled in the Province of Alberta, hereby enacts the following:

### 1 ROAD CLOSURE AND DISPOSAL


- 1.1 That the portion of the road as described below is hereby closed to public travel for the purpose of disposal subject to the rights of access granted by other legislation.

All that portion of Registered Road Plan 872 2638. Excepting there out all mines and minerals

### 2 EFFECTIVE DATE

- 2.1 That this Bylaw shall come into force and have effect from and after the date of the third and final reading thereof.
