### **PROPOSAL & BACKGROUND**

Administration has received a letter from the Bonnyville Regional Water Services Commission (BRWSC) regarding possibly applying to the Province for a 3-way partnership to hook up the M.D.'s current 250 mm supply line to the Cold Lake Regional Utilities Service Commission's (CLRUSC) water transfer station on the south side of the City of Cold Lake (APPENDIX A).

The AECOM report, commissioned by the MD in 2021, is being used as information to base a possible application to Alberta Transportation (APPENDIX B).

The BRWSC is proposing to take the lead on the application and is asking if Council is in support of the application.

### **DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS**

This connection would have the benefit of switching over the disinfection from chlorinated water to chloraminated water, allowing for improved disinfection, and the additional benefit of providing a second supply line for the BRWSC under the Beaver River.

The connection of the 250mm M.D. line to the CLRUSC transfer station will allow the M.D. to fill the reservoirs at Ardmore and Fort Kent with the chloraminated water, improving the water quality, while keeping service to the residents connected to the 250mm line and with minimal increase in operational maintenance.
