
To Whom It May Concern:

On March 25, 2021 grazing permit GRP870028 was cancelled. I paid the annual taxes of \$27.20 on Roll #6406053001 on Sept 8, 2021. This was an overpayment of \$20.40. I also paid the annual taxes of \$25.37 on Roll #6406054001. This was an overpayment of \$19.03. I received tax bills for the above land in 2022. I spoke with Tina Flack and she said she would look into it. I continued getting tax bills plus penalties for 2022 for the next 2 years. I have been in to the office several times and can not seem to get this resolved.
