PROPOSAL & BACKGROUND

September 24, 2024, the M.D. administration approved \$56,000 for the development of a Municipal District of Bonnyville Regional Airport Masterplan. The Airport Masterplan supports councils' economic development aspirations for the community. The masterplan will help identify the costs and benefits of potential future upgrades and expanded operations of the airport.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

The development of an Airport Development Economic Impact Assessment and Airport Masterplan are a crucial part of an overall investment attraction plan that includes the promotion of land and building sales at the adjacent industrial subdivision to increase M.D. revenue.

The Airport Masterplan will include analysis of the airports current economic, social, and emergency management benefits and overall utilization levels. The masterplan will also include airport activity forecasts, 20-year proforma and assessment of airport aeronautical fees and lease rates, resource guide for improved grant applications, and creation of an overarching vision and strategy for the airport that will prevail through changeovers in administration.
