**Title:** Policy No. C-5C.021 Surveillance System Policy – New

#### **PROPOSAL**

Administration has prepared a draft policy to address use and access for records created by surveillance systems installed in M.D. of Bonnyville facilities and on municipal property.

#### DISCUSSION

With the increase to theft and vandalism over the last several years, the M.D. made the operational decision to install additional surveillance systems on municipal properties to help protect its assets and infrastructure.

As a result of this increased use of surveillance, Administration has drafted a new policy in recognition of the importance of ensuring surveillance data is managed securely, consistently, and in compliance with legislation. With increasing emphasis on the use and management of electronic data and records, it is essential to have clear guidelines in place for M.D. staff to safeguard sensitive records and prevent misuse or unauthorized access.

This policy will support the M.D. in maintaining proper records management practices, ensuring that all surveillance data is securely stored, organized, and accessible only to authorized personnel. This will enhance accountability, protect personal privacy, and reduce the risk of data breaches, fostering trust within the community while protecting the integrity of the M.D.'s operations.
