

# MD Infrastructure Patrols

Many of our Patrols focus on the protection of MD properties and Infrastructure.



# Focused on Industry

- We partner with CNRL, Baytex, Cenovus, and Imperial Oil to deliver patrol services on their well sites and service roads.
- In the First quarter of 2025, we delivered 497 hours of patrol services to our industry partners on a fee for service basis.
- 135 tickets were issued during these patrols.

# Commercial Vehicles

Many of our Peace Officers are trained to inspect commercial vehicles for safety violations.

During the First quarter of 2025, MD Peace Officers conducted 25 commercial vehicle inspections, resulting in 6 vehicles being temporarily put out of service.


This quarter 31 warnings and 11 tickets were issued for various safety offences.





## Highlights ...

- ✓ 1 X 24-hour suspension to driver while operating motor vehicle under the influence of crystal meth
- ✓ 13 tickets/warnings was given for fail to stop before entering intersection fail to obey stop sign/traffic control device.
- ✓ 1 ticket was issued for distracted driving.
- ✓ 4 tickets/warnings issued seatbelts
- ✓ 11 tickets/warnings for aggressive driving which included
  - driving at an unreasonable speed
  - speeding at least over 50 km over the speed limit
  - unsafe lane change
  - pass/overtake when unsafe
  - improperly cross solid line.



## Patrol Facts

- Recorded 22 Assistance Rendered files (1 Cold Lake Fire Department, 6 General Public, 1 MD Department, 6 RCMP, 8 Other Agencies)
- Attended 6 Motor Vehicle Collisions
- There were 9 incidents of fail to stop for a Peace Officer.
- The highest speed recorded was 170 km/h on Hwy 657 near township road 604A. During the incidents speeds ranged up to 72 km/h **OVER** the posted speed limit as the one on Twp 630.
- Issued 17 summons for court 2 tickets for suspended drivers, 6 for speeding and 9 for driving without insurance
- Arrested 3 people who were wanted on Provincial Warrants.
