Re: Urgent Request for Support Regarding Private Child Care Funding in Cold Lake

Thank you for taking the time to read this letter and for the outstanding leadership you continue to demonstrate in support of our region. Your dedication to the well-being of our residents, and your commitment to strengthening the social and economic fabric of Cold Lake and the surrounding area, is deeply appreciated.

I was recently informed by a constituent about a significant change to Alberta's childcare funding policy; as of May 15, 2025, the Government of Alberta has implemented a new measure that restricts affordability grant funding for new private (for profit) childcare spaces, due to a federally imposed cap under the Canada-Alberta Canada-Wide Early Learning and Child Care Agreement (CACWELCC).

While existing licensed private programs with signed grant agreements will continue to receive funding, new private centres will only qualify if they open in one of five "high waitlist" communities: Grande Prairie, Red Deer, Lethbridge, Fort McMurray, and Canmore/Banff. *Cold Lake was not included on that list*—despite the urgent and growing need for childcare in our region.

This decision comes at a time when hundreds of military families, oil and gas workers, and other parents in Cold Lake are already struggling—right now—to find childcare placement for their children. Waitlists are long, spots are scarce, and the few providers operating in the area are stretched to capacity. This is not a future problem—it is an existing crisis that is about to get worse.

The shortage of accessible childcare is already having concrete consequences. *There are well known cases of skilled professionals who have declined offers to relocate to Cold Lake specifically because they were unable to find childcare.* Employers across sectors report that the lack of spaces is directly impacting their ability to recruit and retain talent. We are standing on the threshold of a true crisis, and unless Cold Lake is added to the list of high-need communities, the opportunity to avert it may be lost.

I am requesting you consider writing a letter to the Minister of Education and Child Care, advocating for Cold Lake to be granted an exception to the current policy and added to the list of high-priority communities eligible for new funded private spaces. I would request you send your letter directly to the Minister of Education and Child Care and kindly CC my office, so we may include your voice as part of our broader advocacy on behalf of local families and childcare providers. Once your letters have been submitted, our office will prepare a formal request for a meeting with the Minister of Education and Child Care. This meeting will include myself as the MLA, along with representatives from the municipalities supporting Cold Lake's inclusion on the list of high-priority communities. Our goal is to present a united and collaborative front in urging the Minister to recognize the urgent need for expanded childcare access in our region.

I would like to note that this policy decision was made by the Honourable Matt Jones, Minister of Jobs, Economy and Trade, in one of his final actions involving childcare before the creation of the new Ministry of Education and Child Care. We are grateful that the Honourable Demetrios Nicolaides has now taken on this important responsibility last week, and we are confident in his willingness to listen to communities like ours as he assumes this critical portfolio.

Please feel free to contact my office if you have questions or need assistance in drafting your response. I believe a coordinated appeal from key community leaders—including municipal officials, federal representatives, and CFB Cold Lake—could be instrumental in reversing this oversight.

Thank you for your leadership and for your ongoing commitment to Cold Lake families.
