Title: 2025 Substitute Returning Officer – Change of Appointment

PROPOSAL & BACKGROUND

Council appointed the Returning Officer and Substitute Returning Officer for the M.D. 2025 Municipal Election on January 28, 2025.

Due to unforeseen circumstances beyond their control, the current Substitute Returning Officer is unable to fulfill the RO duties at this time and Administration is seeking Council approval to revoke this appointment and appoint a new Substitute Returning Officer.

DISCUSSION ON BENEFITS, DISADVANTAGES & OPTIONS

As per the Local Authorities Election Act (LAEA), Council may appoint a RO for a municipal election and **must** appoint a Substitute RO for the purposes of conducting a municipal election; and these appointments must be done on or before June 30th of an election year.

Administration consulted with Municipal Affairs and confirmed that Council could withdraw the existing appointment and re-appoint a new person as the Substitute Returning Officer since the change is occurring prior to the June 30th deadline.

To help ensure the necessary availability and support required from this role throughout the remainder of the year, Administration is requesting that Council withdraw the current appointment and re-appoint Kelsey Laye as the Substitute Returning Officer for the Municipal District of Bonnyville 2025 Municipal Election, effective immediately.
